### **Technical Committee Report – Dave Saffel**

- Equipment testing Testing has begun on the Motorola NEXT radio that was provided.
   Motorola has not provided the number of required radios, chargers, cables, and software.
   Testing that was started showed that the radio did not include Encryption, Multikey, and Intelligent Priority Scan. Pete Marotta is supposed to be getting that capability and providing update to this radio. Approval of testing will not be complete until Motorola has provided all required equipment.
- Testing has also concluded on the Kenwood VP8000. This is a multiband (VHF, UHF, 700/800 MHz capable). The capabilities of this radio pretty closely mirror the APX8000. Following the December meeting, further testing regarding regrouping and inhibiting indicated that it behaved in a manner similar to the APX. This radio is considered to be approved and will be added to the AEL as Level 1 when all equipment is delivered from Kenwood.

- Public Broadcasting requesting installation of a TV antenna on the Cabela's tower in Wheeling. That tower is overloaded already. The tower is owned by Ohio County and they need to be consulted.
- Roane General Hospital is starting an EMS service to supplement Roane County EMS and asked for talkgroup creation to conduct business and application for participation. No objection from the Technical Committee.



- Barbour County request two talkgroups to begin using encryption for their county government and 1 talkgroup for there "Here and There Transit" that conducts checks on the elderly of the community. No objection from the Technical Committee.

- Trunk Trailer usage in Shepherdstown The trunk trailer was taken to the town and set up by SIRN technician. It was set up restricted to Jefferson only, and beyond that to largely Shepherdstown talkgroups. Public Safety users are reporting that they have coverage in locations that they had nothing before. A frequency search was done and frequencies were discovered to be possible due to the low elevation of the site. A problem occurred during testing recently was Emergency Activations occurred and no real activation could be identified. It is believed that the activation occurred in part due to the transport being used to connect to the system.
- Lost/Stolen Radio's Discussion Used to regroup them to the lost radio talkgroup. RC Faulk discovered that only works if the laptop programmer enables regroup. If you turn it off in CPS, the radio ignores the command from the Astro platform and the radio works like normal. Testing on the APXNext and XTS2500 it appears that the "radio inhibit" feature is mandated to be ON and can't be turned off in CPS. If an inhibit command from the platform is issued, can we be reasonably sure a radio is disabled and can't be used for nefarious activities. How do other manufactures treat regroup and inhibit abilities being mandated on or off? Can the laptop operator shut it off or not? The fact that it seems possible for the radio to be told to ignore what we thought was a good thing.
