<u> Technical Committee Report – Dave Saffel</u>

- Equipment testing
 - Testing continues on the Motorola APXNext. All of the test radios have been received and the committee continues to determine what it does and does not do like a Standard APX.
 - Testing is complete on the VP8000. It is tentatively approved pending arrival of all of the demo radios.

- Low Power Pool use It has been discussed for a long time about having simplex channels for use in conjunction with the system while not using repeaters. Low Power Pool channels could be a very good way to accomplish this, but it has not been broadly done. Entities should consider licensing Low Power Pool channels to use for Fire Ground and other simplex uses that would not benefit with SIRN.



- Gilmer County Law Enforcement, EMS, and Fire all dispatched out of Lewis County. Lewis County is hearing them broken. The only tower that they felt that they could talk through is Roanoke. It is believed that the issue may lie at the Lewis 911 Center on a control radio.
- T-Mobile submitted documents for site updates at Five Forks and Amsted. Structural analysis indicates at this point both sites pass structural testing. The Technical Committee has no objections.

System Upgrade –

Jeff – Data base frozen, 2/1, no changes/modifications etc. Data base is in the labs currently. This week software being uploaded to routers, switches, etc. Could be a brief period of site trunking several seconds. Direct Connect should not have any issues. Jeff then went over a Power Point, which had been given to all of the directors previously. Master sites will be upgraded as well. Going from 7.18 to 2021.1. All site upgrades will be staggered no sites which neighbor others will be upgraded at the same time. Aviat upgrades will cease during upgrade. Will resume sometime after the Motorola upgrades. Monthly security patches have been discontinued until after the upgrades have been made. Most impacting to the centers will begin the week of February 27th. Jeff went over those from Motorola who will be involved in his County for the upgrades, unsure if this is the same for all centers in our region or not.

Kinder - Will not impact any of the users in the system. Should be transparent to the end users. Important that SIRN team kept in the loop if there are any unexpected issues during the upgrades. Coverage area impacts etc. Largely transparent.

Kinder – Region 3 – antenna replacement, Cacapon, North Mountain, after the upgrade.

Shepherdstown – Site 32 (mobile trailer) may not be operable after the upgrade. Improved radio functionality due to the site. Lori – the site has been a big help to them.

Policy/Procedure – Final draft of Procedural Rules. Additions – covered by WV codes, vacancies and terms reviewed. Sandy asked if he had any input on the policy. He asked about the verbiage of the West Virginia Division of Emergency Management. It was discussed and it will be remaining. Elections discussed.

Review with voting members about open positions – Chair, Vice Chair. Bill Christian made a motion to nominate Jeff Polczynski as Chair and Chris Fincham as Vice Chair. Tad seconded the motion. Discussion: Jeff expressed his opinion on the requirement to be physically present at the SIEC meetings. Stated that "for a technical committee, technology should be fully utilized". It was noted not to install any Motorola Firmware above 27.

Each agency present had an opportunity to talk about improvements, changes, concerns, and challenges with the SIRN system within their agencies/counties.

Trainings:

- Working to have a programmers training.
- A List of upcoming communications related classes can be found on the Course Mill site. It appears that the pre-requisite of having NIM 300 & 400for some classes may have limited some participants.
- Possibly of having a 300 & 400 training needs to be investigated.

Regional Radio Testing – It was the consensus of the group that this test should continue from the 911 centers. It appears that the 1^{st} Wednesday

of the month would work best. Noted that each 911 center should have been provided a Motorola ASTRO for the SIRN system.

A working discussion was held relating to encryption for radio's used in the regional SWAT Team.

The WV EMD is considering purchasing two trailers to be use with First Net having Band 14 capabilities.

AEDs – Dirk noted that all AEDs need to register with the state and that all county OEMs and 911 centers should have a list of their locations.

Next Meeting – March 6, 2023, at the Randolph OEM/911 Center.
