#### **CALL TO ORDER**

• The meeting was called to order at 10:00 by RIC Chair John Zilinski.

#### **APPROVAL OF MINUTES**

 There was not a quorum present at the last meeting in December. No minutes were prepared or presented.

#### **TECHNICAL MEETING**

- Mr. Zilinski spoke on the technical items from the agenda. There was a general discussion regarding the Motorola APX 29.00.03 MEGA Firmware 29.02.00. He indicated that he updated his radios with no issues however, Mr. Lord updated to the same software and firmware and his radio will no longer connect or affiliate to the system. The only difference between Mr. Zilinski and Mr. Lord's radios are TDMA capability. Mr. Zilinski sent an email to Dustyn McConnell advising him of the situation and no response has been received at this time. Kevin White also offered to assist with this issue.
- There were no changes on Motorola CPS or the Kenwood 10 or 20 series. There were minor changes to the Kenwood 30 and Armada radios and there was a general discussion among the group regarding those.
- Mr. Zilinski also provided the statistics from February 2023 and they are as follows:

Calls: 2,749,424 PTT: 3,271,581 Busy: 7,057

Additionally, he requested everyone to please notify a technician should they experience and extreme number of busy signals.

- Mr. Zilinski presented information regarding the policy of Radio Equipment Requirements and the Approved Equipment List. Hopefully updates to these will be done by April 21, which is when the HSGP (Homeland Security Grant Program) Applications are due.
- The SIRN update is almost complete. Still working on several recorders through the state.
   Richard Filipek indicated there were some issues in Raleigh County. All updates should be finished by next week.
- The database is now unlocked to add or change ID's. A total of 1,387 pieces or equipment were updated.
- VP 8000 radios were approved at the last SIEC meeting.
- APX NEXT radios have been received and are being tested.
- WAVE App has been tested. The second round of testing is scheduled to go out. This app is for cell phones and basically turned the phone into a radio. A subscription is required but there is no information on pricing at this time. If interested, contact Pete Marotta for pricing.

#### **POLICY AND PROCEDURE**

- Approved Radio Equipment Requirements
- The policy committee is developing a SOP for working on Communication Towers for SIRN.

#### TRAINING AND OUTREACH

- The INCM class was completed a few weeks ago in Flatwoods. This was a very good class and there should be another offering later in the year.
- INTD class coming up next week in Flatwood was overbooked. FEMA is bringing in a second instructor to assist. There was a big push by the E-911 Council TERT Committee for Telecommunicators that were interested in being apart of the WV TERT Team to take this class. An overview of the TERT Committee was given by Mr. Fortner. Theresa White requested to add herself and Sandy Green on the project and there was a general discussion of the current items that the TERT Committee were beginning to work on.
- AUXCOM class is being held at the Raleigh County 911 Center on March 25-26. The instructor is
  Jim Mangus from Kanawha Metro 911 Center. If anyone is interested, please register through
  CourseMill. Jim Mangus indicated that people can still take the class, even if they haven't taken
  their test yet. He will hold their certificate until they have their license. Chris Hatcher indicated
  there was a test session on Thursday, 3/16 at WJLS in uptown Beckley.
- Several programmer trainings coming up at the WV Public Safety Expo. If interested, send
  programmer application to RC Faulk and register for the individual courses through the public
  safety expo website.

  - Thursday, May 12 Armada (Kenwood VP Series)
  - Friday, May 13 NX Series

#### **CONFERENCE**

- The SIRN Conference is September 24-28 at Camp Dawson in Preston County.
- The Conference committee is looking at training sessions that would be of interest. Mr. Zilinski asked the group if they had any thoughts or suggestions on what they would like to see at the conference.
  - Kevin White indicated that Motorola was looking into having a user group session for those agencies that use the Motorola Flex CAD. Currently, WV is apart of the SERSUN group however, Motorola is looking to make a user group just for the state of WV since there are so many Flex customers. This conference may be a good place to host this meeting.
  - Cody Fortner proposed a training session for console patching for user that utilize the MCC7500. He indicated that this isn't something that used a lot but, may be a good training opportunity on how to use the functionality and the affects that it would have on the system.
  - Mark Pickett spoke on the regional exercise that he did with the regional health departments, hospitals, and emergency management. Hospice of Southern WV seemed to have some issues and they have since been in contact with Mr. Zilinski to have those resolved.
  - Kevin White also stated that the WV COML class was a good class and it would be good to bring it back to the conference.
  - Mr. Zilinski indicated that he would like to see a RADO class at the conference and if there were any other ideas, to let him know.

#### **PLANNING COMMITTEE**

- Mr. Zilinski gave an update on the following items:
  - T-Mobile equipment going on Greenbrier Tower
  - Chris Hatcher License frequency to change names and renew at Beckley site.
  - Hinton Perry still working to get contract for building at construction. There was a general discussion with Steve Lipscomb on this project.
  - Nicholas County was approved for direct connect console connected from the Lone Tree site to the new 911 Center at the old Summersville Post Office with an Aviat microwave.
  - Richwood Dave Saffel has five pairs of frequencies for this site. He has requested the SWIC and a technician to cist the site and report on building and generator size, electricity, and other items that may need attention.

#### **CURRENT AND EMERGING TECHNOLOGIES**

Mr. Zilinski gave an update and presented information regarding the AT&T miniCRD for Firstnet.
 Battery last for about 2 hours. Requires a power source. Base price listed at \$34,995. This did not include satellite data.

#### **COUNTY / AGENCY NEWS**

- McDowell AT&T wanting to install antennas on a few towers. Also requested to know if anyone
  was having issues with Pocahontas Land Co. on Lease Agreements. There was a general
  discussion from the group regarding lease and rent agreements.
- Nicholas New center should be done by July.
- Fayette Met with contractor last week on Aviat microwave. Mr. Walker indicated he would get
  with Philip to get an update on the MCC7500 project. He also requested additional information
  on the approved equipment list for purchasing requirements. Mr. Zilinski explained the
  reclassification process. Mr. Walker also requested a copy of the by-laws to see what positions
  need to be filled. Mr. Zilinski indicated that he will be sending those out to review and update in
  the future meetings.
- WVEMD Train the Trainer course on the AAIR T3 class. Theresa will send the flyer to Mr.
   Zilinski, in which can send out to the RIC members.
- Greenbrier Still working on funding for their MCC7500 project. Wasn't aware of the T-Mobile project that was discussed in the planning committee.
- AT&T / HAM Radio / Chris Hatcher If anyone is interested in a HAM radio class, let him know and they will schedule one, if possible.
- Wyoming They were approved to purchase the MCC7500 console. A few other issues must be
  resolved in order to determine if they will be able to direct connect to the core or not.
- Summers Nothing further to report other than the Hinton site as previously discussed.
- Raleigh General Brant Whittaker has been named the new Emergency Manager and Manager
  of Regional Command. He asked the group if anyone would know how many radios were issued
  to RGH. He currently has two portables. Mr. Zilinski asked him to look at the radio ID to
  determine if they were issued by DHHR.
- WVSP Went through the update, everything went well on their side.
- Southern WV Community and Technical Nothing further to report other than radio issues that were discussed under technical.
