- Regional 1-8 TG Secure It is determined that this should be dynamically established for each individual event and programmed shortly before that event. A CKR is determined to be 99 and SECTAC Rx should be programmed into each radio.
- Josh Dwyer discussed operations and security and answered all questions and concerns on the Motorola Smart Connect.
- Kenwood Testing Update Great lengths of testing on the part of Tony Novel and others in that area have resulted in NX firmware of 5.11 appearing to work properly at this point. Motion to return NX to level 1 pending actual release of firmware Tony, second by Dave Erwin. Approved.



- Boy Scout fulltime radio patch & console The only way that an Avtec console could be directly connected would be via a CSSI connection which has yet to be established in SIRN. Recommend any console for use with SIRN be directly connected to make the most efficient use of SIRN resources. If Motorola desires to do proof of concept and fund it, we are willing to work with them at no expense to SIRN.
- Bethany College Dispatch TG request Motion Tom Hart Second Bob Hoge, Approved.
- Report of one-way radio communications It has been determined that the problem is likely caused by P-25 Phase II. At this point, if you do NOT have TDMA (Phase II) in a radio, it should NOT have Channel ID plans 6 & 7 active in a radio. Secondarily, if there is ONE radio actually affiliated (Not SCANNING), then the problem would be less as the TDMA site would potentially be locked in FDMA due to a Phase I radio being affiliated.
- T-Mobile on Snowshoe tower –That is a BTOP tower, and owned by WV EMD. Motion to allow T-Mobile on the tower by Dave Erwin Second Tony Novel, Approved.
- Adding TDMA to a site and subsequent licensing requirement It is necessary to add 9K80D7W to any site to all channels in that site. If we do that through APCO, it will cost \$175 per site for the administrative change. It will need to be done through a public safety coordinator regardless of which one it is and costs to other coordinators are unknown.
- Approval of Smart Connect Motion by Tony Novel to approve, second by Fred Channel, Approved.

- The SWIC has been requested to reach out to BK and Harris for updated radio models with non-expiring software to be submitted for testing. This should include free future access to any firmware updates.
