 - Update on GME mobile radio testing of the unit that Rodney has. Due to length of time, should we wait?
 - Motorola radio Pete gave to us at the March meeting. Upon returning home, Pete contacted me that the radio I had couldn't be programmed. He was going to provide me a program link, which I have not yet received. HOWEVER, he was going to deliver a radio to me, and get the first one at the APCO conference at Snowshoe. It was cancelled, so the swap has not yet happened, so no testing to report.

- System Version Upgrade Status
 - Motorola advised on a 4/10/2020 call that they have made much success with the upgrade using a different upgrade technique. The Motorola team anticipates having additional information to share late in the week of April 13, 2020 about how to proceed with a possible cutover.
 - It is possible that the core cutover could be the week of May 19 with direct connect console locations possibly starting the Tuesday following Memorial Day.
 - RC Faulk will be reaching out to the direct connect console locations to see if there are restrictions on Motorola or SIRN personnel entering the locations during that time to continue the upgrade.

- Mobile Antennas The technical committee is going to create a document of recommendation of antenna types that are desirable for use in the SIRN system. Further discussion of currently installed antennas took place at this meeting
- TDMA Channel ID plan and site assignments Marshall County has requested one site for St. Joes. NOTE: The only decision that was made for this was St. Joes getting to be one of the sites. We still need to make a determination of the Channel ID plan plus which sites are going to get them.
- Adding CradlePoints for redundancy Mark Smith The currently recommended method for connection to the Motorola System is a PRX7000. This is a piece of software that runs a proxy server on a computer and further incorporates a firewall.
- Lick Knob The tower is probably going to have to be moved due to the desire to mine the area under the tower. Tyrone is going to attempt to get coordinates for analysis. Checked with Tyrone April 5, he hasn't heard anything back from them. He will check again, hopefully get something back before this meeting.
- Freq discussions about Hinton (If any needed) Greg Sluss and I had a discussion about the frequencies for Hinton from the Lauttamus group. We did some refarming for it, and then subsequently had a discussion with Motorola with our choices. They determined that the frequencies that we had chosen would work, so barring something being determined later, we are not changing what we assigned.



- Freq discussions about re-farming John Davis and I had a significant discussion of the refarming groups that he has created from the Lauttamus frequencies. There are repetitions in the channels available as the top of one channel is the bottom of the next channel. As such, John has determined that there are only 37 channels rather than the 51 I thought was available. Where the channels are assigned, and will likely require a Working Group at an face2face meeting at a later date. It is not necessary to significantly refarm immediately prior to the upgrade.
- 7.18 license components (what others decided to buy, what some say we should have, et cetera) Depending on time This discussion could take far more than the hour we are allocated. As we have the honor to be allocated an hour, I am going to likely defer this to a later meeting. Again, a face2face meeting might be better for this.
- North Mtn failing SA and cell phone co-locate update The technical committee recommends that any structural change needs to be made at the expense of the company desiring to be a tenant. Following that change, they will be a rent paying tenant.
- McComas site with desire by AT&T to co-locate. Tower fails structural analysis. AT&T wants to add additional equipment and says that once again, the tower fails, and they say that an antenna has been added. We are aware only of an antenna that was replaced in kind and there should have been no other changes.
- North Mountain (Berkeley) Report from Jeff Polczynski on the status of obtaining business frequencies.
- Hinton Tower Site A site has become available from Crown Castle that was proposed for Hinton instead of the currently determined site. It would be ready now. The highest elevation for the antennas would be below 267ft. Hopefully, I can display a study I did comparing the current selected site with the Crown Castle Site.
- Cell Phone Tower Arson Shared to document from Homeland Security
- Motorola has sold a new SIRN site to the Doddridge/Ritchie 911 center. The name is West Union. They did not purchase microwave, but the site itself has been finalized.
- Harris Class We had a request for a system key from one of the students in the class. That student has been sold a Master Dongle improperly. The recommendation of the technical committee is that Harris should recover that Master Dongle from the purchaser. Motion to cause Harris to recover the key, and he would be provided a single key. Second by Jeff Polczynski. Passed.



• Future Hardware Master keys for any manufacturer will be held by the SIEC or designee and only daughter keys, or controllable single computer software keys will be given to programmers. Tabled for this meeting to be discussed at the next meeting.
