 - Motorola CPS 20.01.00 Firmware 20.50.10
 - Kenwood KPG-95DGN v 8.30 (10 Series) Firmware 4.43 (v2) 6.14 (v3)
 - Kenwood KPG-112DN V2.33 (20 Series) Firmware 2.21
 - Kenwood KPG-D1N 4.51 (NX-5X00 & 30 Series)–Firmware 4.51-adds their version of ADP to the radios if you get the license (no cost)

- There are several sites that are in need of additional channels. Currently, those sites are:
 - o Catherine's ASR Updated, Application has been filed.
 - o Richwood Some frequencies have potentially been located.
 - o Clay Tower Tower Grant has been awarded.
- Pendleton County Has requested a new talkgroup for County Radio Techs to talk on.
 Though there should be an acceptable talkgroup available already in Pendleton County for
 use by their fleet of technicians, it is acceptable for a new talkgroup to be created for that
 use.
- Frequency project update for Catherine's The ASR modification that was applied for from Monongalia County was approved by the FCC. The application based on that ASR was completed and submitted to the FCC for consideration.



- APXNEXT radio conversations with Motorola It is understood that the newest APXNEXT programming is now capable via cable and/or Bluetooth. Either of these would be acceptable to bring us closer to approval in the system. It is encouraged that Motorola provide us with the appropriate material based on current SIRN policy for testing so we may move forward.
- Approved Equipment List (AEL) discussion This list needs to match where appropriate the Radio Equipment list. This would largely be in the section regarding the capabilities of the different levels of radios.
- Use of Service Monitors evaluating radios Lengthy quality discussion on testing of radios with service monitors. Both the Aeroflex 3920B and 8800 models (now Viavi owned) have the ability to completely tune several manufacturers. They are not inexpensive, but they quickly show that many subscriber units, portables especially, are in need of tuning after they have been in service for a while. Any entity that has a significant number of radios would likely find this to be beneficial to their systems as they make non-functional radios operate well when the radios perform their tuning routine. Fred Channel reported that he felt that the use his agency has had using theirs quickly made it cost effective for them.

- Discussed updates to policies that have been out to the members for feedback.
- Final changes were made to several policy documents in preparation for final review and approval at the March meeting.

<u>Training/Education/Outreach Committee Report – Roy McCallister</u>

- Harrison County will host the COMT course on February 28 to March 4 at the old Harrison 911 Center. RC Faulk reported the course is full with a waiting list.
- Another COMT will be held on October 31 to November 4, logistics to be worked out.
- The ITSL course will be coming soon with details to follow.
- The State has requested a WV COML hosted at the Canaan Valley Fire Department on July 12-15. Committee Recommends to Support the Course; John Zilinski seconded; Motion Passed.
- Some logistics remain to be worked out but the group supported having the course. This will be a lead up to a full-scale exercise in October.

Planning Committee Report - Bobby Hoge

- Roane County submitted application for participation for K9 Search & Rescue; It was advised that they could participate as a member of Roane County with access to the Roane talkgroups, Roane 911 and the regional talkgroups but none would be created for their own use. The RIC will reach out to the group.
- Dingess site paperwork is being modified to show county legacy gear as part of the site collocate.
- Richwood site has an additional frequency located for it by the OES Director however a question remains to be answered if it is usable or not.
- Valley site has initial engineering completed on it and additional required studies are underway. The land owner has given the OK for the site to start being cleared.



- Hinton site engineering work is with Mead and Hunt and Premier Construction. The IRP gear is sitting in the warehouse ready to go in service.
- Premier Construction has a list of sites for lighting and antenna that need worked on and work orders and estimates are due the State on that shortly.
- David Neal reported that the State is working on a Motorola site contract.
- The tower fund grant was approved for Clay County and they are soliciting help from the National Guard who would benefit from having a site there for the Fola training area.
- Horsepen site that Tim Cole has given verbal approval to proceed with both properties, Forestry and WVSP.
- Princeton site foundation is poured and the AEP survey is complete. The shelter and ASR site is ordered.
- Wileyville project is projected to begin after the weather breaks.
