- Programming classes other than at Conference Discussion
  - We are seeing the need for programming classes other than at the yearly conference.
    In addition, we are getting the need for additional instructors. Keep in mind the following:
    - A class not given by a certified instructor of SIRN is NOT a valid class to program on SIRN
    - Any person desiring to be an instructor must request to do so via the SWIC or the Technical Committee Chair (or both)
    - Any potential instructor must teach one or more classes in the desired radio under the supervision of an instructor certified on that radio.



- All class material must be approved by the SIEC Technical Committee, and ideally, all classes should have enough context material so that when the class is completed, the student may start with either a blank code plug (Some radios require a codeplug from a radio to program) or one created by the software if that is available. At completion, the student should be able to have a codeplug that they can dump into a radio and work. (Software, Cables, and Radio ID's are required and not provided in class)
- For current and future classes, the student must have (though not mandatory to have in class) programming software and programming cables. The SIEC does NOT provide any material for programming other than the syllabus from which the instruction is given. Students historically do better learning if they have the software installed on their computer for class and can follow along.
- We desire to have a group of classes midyear, on a central location of the state to facilitate all to drive approximately a similar distance. We hope to have classes for:
  - Motorola
    - o APX
    - o NEXT
    - o Newer models
  - EFJ/Kenwood Viking radios (Armada)
  - Kenwood D1N software (NX radios)
  - BK Technologies RES
  - Harris
  - Tait
  - Icom
- Many if not all manufacturers are trying to move to hardware keys. Rogue programmers have made it desirable to use hardware keys despite our attempting for many years not to do so. SIRN is moving to support and potentially require hardware keys. Class requiring hardware keys will be notified in advance of that need, and students MUST bring programmable keys with them to the class or the key will potentially not be provided upon completion.
- LOC for Cabell County It is necessary to be good neighbors. It is recommended that we sign LOC's for Cabell County as long as the belief is that they will not create interference for our SIRN sites.



• Snowshoe Rain Gauge interference – There is a rain gauge on Snowshoe that is apparently putting out an 8<sup>th</sup> harmonic. NRQZ believes it may be caused by overdriving the final amplifier. This repeater is a radio that was constructed by a company using radios which would not be considered to be high quality. Technical is recommending that a technician capable of searching harmonics with Spectrum Analyzers, and working to determine if the harmonic is coming out of the radio driving the amplifier or if it is causing the amplifier to create a harmonic.
