- Minutes from the previous meeting, unanimously approved by a motion, T Campbell motioned, Mike Laboric seconded the motion.
- WV Aux Comm, October 25 & 26 Romney, sent registration information out. WVSIRN Conference, radio programming training.
- Old Business
 - S. Yoho advised that the Wileyville/Wetzel tower construction has been delayed by weather. Fence is going up next week. Electrical not completed.
 - Cadel everything signed, all studies done. Steel being ordered.
 - Sand Springs had a bad antenna, repaired and back to normal.
 - Motorola N70's, Next XN, Harris XL400, XL185 and XL 95 still in testing.
 - Upgraded still on the schedule for late September 29th 2025 zone 1 & 2, Oct. 6th zone 3.
 - Sand Springs had a bad antenna, repaired and back to normal..
 - Non AIS centers already updated, AIS centers will be updated after the upgrades.

 - Radio approval was made for TAIT 9800.
 - ICE brought a block of RID's to SIRN and were issued TG's.
 - Federal Real IDs are required to get on Base at Camp Dawson for the radio conference. (Star in upper corner of your drivers license)
 - For those attending WVSIRN Conference and taking either BK or L3 Harris classes, in order to leave the conference with a programming key, you must have a distribution key that will be authorized. No Master Keys will be authorized.
 - Technical Committee would like to recommend all radios in Level 1 have the ability to do Mixed Mode Priority Scan feature.
 - Secure Regional talkgroups were discussed stating that 95% of the radios on the system do not have them. ie Region 1-8 Secure. AES encryption must be feature in radio.
 - Dispatch OP stations should not be rebooted September 8th and 9th. Updates will be sent out at this time.
 - Discussion at SIEC on an Air to Ground TG in addition to HELO 2, recommendation to assign Regional TG in Region 1-8 by RIC chair.
 - 56,000 radios on the system, all radios should have all 8 regions programmed into them if the capacity exist.
