- It has been noticed during the microwave upgrades that there has been damage to both waveguide and a dish on a tower. SIRN technicians need to accompany all tower crews to towers and truly supervise what they are doing. It is not good to get distracted by anything while performing this task. Constantly monitor what is happening on the tower. Bring a chair in which you can sit and look up constantly.
- Co-Location- The above message regarding monitoring the crews at a tower doing anything becomes even more important when they are not crews that we are used to. If damage is occurring on the tower, we need to know exactly who has done it and what has been done and if possible, photo evidence that it has occurred, how, who, etc. We need to get the policy that was created not very long ago and see what is covered in it and not, modify as necessary.

- A suggestion has been made that as we are doing the upgrade, it would be an opportunity for Points of Contact to go through their radio ID's and report those that are no longer in use. This is especially appropriate for groups of radios that have been replaced by other groups of radios, leaving the original group of ID's no longer in use. It is possible for system administrators to log groups that are not in use, and appropriate for them to disable those IDs. We do NOT have enough radio ID's and in the past, users have not provided the largest number of them. Please police your OWN radio ID's rather than forcing someone that might accidentally turn on one that is currently in use but has not been turned on for months or even years.
