- 3) Kanawha County use of Garfield tower and building for microwave link to Metro AVIAT has conducted a path survey. The antenna at Garfield needs to be installed at the 230 level with 6-foot dishes. Makes sure it is OK with the tower owners, and console in conjunction with technicians. The SIEC technical committee is in agreement with this direction.
- 4) Paging testing Kanawha County is experimenting with paging. It is possible that some increase in capacity is necessary and desirable in that area to make that area work better if anything.
- 5) SWIC and Chair contacted AVIAT regarding system upgrade, possible SUA like Motorola, a phased approach, and any other possible methods. A meeting to discuss things with technicians and others that needed to interact with them was held. AVIAT is attempting to come up with a package to potentially present to the Legislature for future needs.
